### 2. Special Order of Business

ADEX Meeting Report: Dr. Russell Chin reported on the latest ADEX activities and explained what ADEX was all about for people new to the subject. He advised that nearly all states accept the ADEX exam for initial dental licensure (exceptions are NY and Washington DC). The Compedont simulated tooth is being utilized in the examinations, and is very similar to natural tooth structure in handling characteristics. Due to the pandemic, clinical examinations are not occurring, so the exams are being conducted using typodonts and Compedont. Dr. Chin announced the latest officers of ADEX, and described any testing modifications. An upcoming annual CDCA meeting will be held virtually.

## 3. Presentation of the December 2, 2020 Open Session Minutes

Following notification of a typographical error that did not affect meaning, and upon a **motion** by Ms. Jones-Bridges; **seconded** by Ms. Galleshaw, the December 2, 2020 Open Session Minutes were unanimously **approved**.

### 4. Report of the Chair

Dr. Marian Royer welcomed the attendees and wished them a Happy New Year.

- Dr. Royer's reported that a previously approved Board draft relating to Teledentistry is out for review by Ms. Lauren Gareau, Rules Coordinator. After review the draft will be returned to the Board with any suggested changes, and later followed by a period for public comment.
- CDCA hosts a virtual meeting this week.
- Dr. Royer attended a meeting of State Board Chairs and Administrators.
- CCRI is in the process of working to fill the Clinic Manager position. Concerns have been expressed about the viability of the CCRI Dental Assisting program.
- Yankee Dental Congress will be held virtually.
- Dr. Royer commented that dentistry is essential healthcare, and that the responsibilities are overwhelming.
- Many dental personnel have expressed interest in becoming vaccinators.
- The Rhode Island Dental Association is working on the issues of distribution and application of vaccines. There was a strong sentiment expressed that dentists and dental personnel should be prioritized to receive the vaccine, especially since they work in close proximity to patients who are not wearing masks, and in an environment where aerosols are produced.
- Our next meeting will be on 6 January 2021.

- The Board voted unanimously to permit Dr. Zwetchkenbaum bring up the topic of tooth whitening. A vote to introduce a subject that is not on the agenda is limited to discussion only.
- A discussion took place discussing the application of 'gemstones' to teeth by individuals that are not licensed dental professionals. No action was taken at this meeting.

Regional Testing for Initial Dental/Dental Hygiene Licensure: <u>Motion</u> was made (Dr. Burdiel), and seconded (Ms. Galleshaw) to <u>Accept for initial licensure either in-person patient based clinical examinations, or, the typodont/Compedont examinations, beginning now and into the future.</u>
 Discussion ensued, and by a unanimous <u>Vote</u> of the Board, the <u>motion carried</u>.

## 9. Public Comment

• Dr. Chin thanked Dr. Zwetchkenbaum and RIDA for their work related to COVID-19. He questioned why there are no dentists on the Vaccine Advisory Committee. Dr. Chin expressed that dentists should be allowed to administer vaccines.

## 10. Motion to Adjourn to Closed Session

• **Motion** was made by Dr. Cassidy, and **seconded** by Dr. Zwetchkenbaum (at 9:50AM) to adjourn to Closed Session pursuant to Sections 42-46-4 and 42-46-5(a)(4)of the Rhode Island General Laws. The Board voted unanimously to adjourn to Closed Session.

## 11. Motion to Return to Open Session

Motion to return to Open Session was made by Ms. Cassidy, seconded by Dr.Duhaime at 11:10AM., and unanimously approved. Pursuant to Sections 42-46-4, 42-46-5 and 42-46-7 a motion to seal the minutes of the Closed Session (motion-Ms. Galleshaw; second-Dr. Zwetchkenbaum) was voted and unanimously approved.
