MEETING OF THE COORDINATING COMMITTEE OF THE HOUSING RESOURCES COMMISSION PUBLIC SESSION November 29, 2021

Members of the Coordinating Committee of the Rhode Island Housing Resources Commission ("HRC") met on November 29, 2021, in Public Session, beginning at 11:00 a.m., pursuant to the public notice of meeting, a copy of which is attached hereto as **Exhibit A**, as required by applicable Rhode Island law.

The following members were present and participated throughout the meeting as indicated: Ann Nolan, Nick Retsinas, and Carol Ventura.

Committee members not present were: James Thorsen.

Others present were: Michael Tondra, Hannah Moore, Scott Sawyer, Esq. and Christopher Fragomeni, Esq.

1. CALL TO ORDER AND OPENING REMARKS.

Ms. Nolan called the meeting to order at 11:08 a.m., indicating that a quorum was present.

2. <u>HOUSING PRODUCTION FUND – DISCUSSION REGARDING USES OF FUNDS</u> MADE AVAILABLE TO SUPPORT HOUSING/HOMELESS NEEDS.

Mr. Tondra discussed a packet that was prepared by Rhode Island Housing and Mortgage Finance Corporation ("RI Housing") that described the States investment in housing. He also noted that approval of the \$50 million Building Homes Rhode Island ("BHRI") program.

3. <u>BUILDING HOMES RHODE ISLAND/AFFORDABLE HOUSING BOND – DISCUSSION REGARDING USES/POLICIES OF STATE AFFORDABLE HOUSING BOND RESOURCES.</u>

Mr. Tondra explained that there will be a recommendation to the HRC to approve \$31 million in requests under the BHRI program. He also explained funding considerations, including increased costs, timelines, and contingencies for securing additional sources of funds.

4. <u>AGREEMENT WITH RHODE ISLAND HOUSING – DISCUSSION REGARDING CONTRACTUAL RELATIONSHIP(S) BETWEEN THE HOUSING RESOURCES COMMISSION AND RHODE ISLAND HOUSING.</u>

Mr. Tondra explained that the Committee's enabling legislati on discusses the creation of a memorandum of agreement between HRC and RI Housing. He indicated that such agreement is being drafted.
