# 14. Discussion on upcoming 2023-2024 Budget, and future meeting schedule. \*

Budget discussion was primarily dealing with compensation and the apparatus equipment fund. Mr. Holt voiced a concern that we need to be more aggressive with allotting money into the apparatus fund. We need to make two major equipment purchases in the near future (rescue and tanker) and we have to contribute funds to apparatus with this in mind. The current budget funding is not adequate.

Ms. Cottrell commented that apparatus has been in discussion for the three years she has been on the board, and nothing has yet to happen. She noted that at least we should start by committing to a piece of equipment and get in the queue for production.

A budget meeting is scheduled for March 1, 2023 at 7 pm.

# 15. Open Forum.

Jillian Proulx asked if the board has considered having fundraisers to help with generating income for the district. It was explained it's hard to get enough help to take on a fundraising project.
