The Chief reported that the out of service hose at the Greene station is not of any use to WCFD as we use a different size hose and it is in "as-is" condition. West Greenwich (Hianloland) was interested in repairing the hose to use on their apparatus. They also respond on automatic and mutual aid calls, so the hose will be recycled to be on service for our calls. The Chief will prepare a letter per SAP 4570 to document the donation and to release any liability with this donation.
