Mr. Mays questioned why the high increase in rescue calls, over 70% from previous year? The Chief replied that in the town they are probably doing 1-2 psych evaluations each day adding to the normal call volume. We are also still responding to a large number of mutual aid calls and we are probably responding to assisted living/nursing homes about once a day which is higher than normal.

The Chief reported that the West Greenwich rescue has been on loan to WCFD while our rescue 8 is being serviced. Routine maintenance is due on their vehicle and repair is needed to the exhaust tip. He recommends we take care of these expenses.

# 10. Discussion and update regarding the floor Motion from Bob Hevey at the 2024 annual meeting, that the board of Directors shall form a taxpayer study group to evaluate the feasibility of continuing with the present fire department structure. The study group shall be independent of the board and shall select its own chairperson and shall meet at the WCFD station. \*

Mr. Hevey presented the BOD with an explanation of the motion guidance. Specifically he presented the following: that the study group will determine the feasibility of continuing with the present fire department structure, a background of the present structure was presented, having a goal of completing the study in six months, and to determine if other fire department structures are more feasible.

Mr. Hevey reported that so far the members of the committee include himself, Skip Mays, Glenn Underwood, Bob Taylor, two board members TBD, and two Department members TBD. The committee is awaiting approval from the board and appointment of the members.

# 11. Discussion and update of Chief of WCFD search Committee. \*

Mr. Mays reported that the committee has had a meeting this month. They identified a series of points that need to be addressed. Including HR guidance, full vs part time, and administrative needs. There is a meeting on July 1. The Fire Department Structure committee could provide additional guidance if anything comes up in their discussions.

# 12. Discussion on New Member request for financial assistance with EMT-Cardiac Basic Class.

The Chief reported that a new member has requested reimbursement for the EMT class they are taking. This member does not have any qualifications. The Chief has recommended that the board wait until after they successfully completed the class to provide reimbursement and this should be reflected in the SAP.

#### 13. Discussion and response by the Board regarding state bill H-8077.\*

Mr. Mays reported that *H*-8077 has easily passed in the RI house. Representative Chippendale added some beneficial wording, but is still vague and implies that the fire districts need to offer real and tangible assets to the town first. Bob Hevey noted that that the latest version is Sub1 and included the dissolution wording so it did not impact normal liquidation of excess property.

It is assumed a similar bill will need to be proposed to the state senate.

#### 14. Discussion regarding future committees.

Mr. Bousquet noted that there is a need and interest to form other committees. He asked the BOD for suggestions.

The following ideas are noted: fix the financial budget spreadsheets and make them more accessible to view at meetings, fixing the electronic technology, and structure and accessibility of SAP's. This is open ended and future ideas and discussion is welcomed.

15. The Board of Directors of the Western Coventry Fire District will go into Executive Session pursuant to R.I. General Laws 42-46-5(a)(2) re: Gaustini claim mediation..

Mr. Bousquet moved that pursuant to R.I. Gen. Laws §42-46-5(a)(2) litigation, the Board of Directors of the Western Coventry Fire District go into executive session to discuss the status of the Gaustini claim Mediation.
