PERSONAL EXPRESSION

COUNCILMAN GONCALVES Requests the privilege of the floor to speak on a Point of Personal Expression and states:

"I just want to say that the Jewish Alliance of Greater Rhode Island actually sent us a letter and it's the largest Jewish Organization in the State, it services 25,000 members of our Jewish community, and the Board of Rabbis of Greater Rhode Island also sent us a letter to oppose this ordinance. The Jewish community is not a monolith as we all know and while there is disagreement in the Jewish community, when it comes down to it I believe in my heart that the greater community welcomes efforts that are practical and effective achieving lasting peace in the Middle East for both Israelis and Palestinians. The deeply emotional Israel and Palestinian conflict is one of the most complex and emotionally charged issues in modern history. What happened on October 7th is horrible. What's happening in Gaza and in Israel is horrifying. The tragedy, the deaths, the destruction, the innocent lives being lost. No one is denying that and my heart goes out to everyone who is involved. Israel has a right to exist. This proposed ordinance is outside the purview of the Providence City Council and creates and atmosphere of isolation and we've heard this from many of our Jewish neighbors and from many Jewish residents across the City of Providence. Also, the City of Providence does not currently hold any Israel bonds. The fact of the matter is, this ordinance would be largely symbolic with no practical effect on our city's investments and further more by singling out Israel I believe that is anti-Semitic. By taking a stance through this ordinance I believe that we are deepening the divide within our community and we've heard that from many of our Jewish neighbors. So, I do reject this effort to demonize Israel and to alienate Providence's Jewish community. We can criticize the Jewish government absolutely for the atrocities that are being committed, I meant to say the Israel government for the atrocity committed, but that's a very different think here. So, by taking a stand on this ordinance I think we're deepening the divisions in our city. So, I strongly believe that what is needed during this deeply painful moment in this complex conflict is constructive and respectful dialogue on how to support lasting peace in the region. I don't know how this does that. So, I hope that we can focus on fostering unity in our community and support each other to make a difference that's meaningful in the lives of people who live in the great City of Providence. Thank you, Madam President."
