Dr. Libutti shared that URI's summer enrollment is up 8% (over 4,500 students). He said that Fall 2024 new student applications hit a record 26,945 – over 1,500 more than last year. URI has awarded financial aid to over 13,000 students/families so far. Regarding Fall enrollment, URI has over 3,170 enrolled so far, and the target is 3,235. Dr. Libutti reported that the transfer student enrollment target is 520; the pool develops over the summer and is moving forward as planned.

Ms. Markeisha Miner, Vice President, Community, Equity, and Diversity

Vice President Miner informed the committee that URI has made significant progress regarding faculty, staff, and student diversity over the past year. The allocation of critical resources, dedicated staffing, and inclusive outreach programs have contributed to this progress. She explained that this annual report focuses on the dimensions of race and gender diversity, and that as we celebrate URI's progress over the last decade, URI continues to invest in its greatest asset, its people. And, through continued enhancements to the University's human resources organization, we will continue to build a workforce that reflects the broad diversity of all learners as the state's land grant, public research university.
