#### 2. REPORT OF THE CHIEF ACADEMIC OFFICER

Dr. Barbara Wolfe, Provost and Executive Vice President for Academic Affairs

a. Update on Searches

Provost and Executive Vice President for Academic Affairs Barbara Wolfe updated the Committee on two administrative searches underway; the University Librarian and Dean of the College of Environment and Life Sciences. The search firm Perrett Laver is supporting both searches, which are expected to conclude by the end of the academic year.

b. Update on Fall Enrollment Report

The Provost introduced the enrollment update by noting that URI has a Fall 2024 enrollment of 17,352 Students, and then turned to Dean Libutti, Associate Vice President of Enrollment Management and Student Success. Dr. Libutti noted there were record high undergraduate applications this year. Undergraduate enrollment was challenged by FAFSA fallout. The University saw growth in graduate programs, especially online and in-person master's programs.

Responding to trustee inquiry, Dr. Libutti offered to provide via email an overview of enrollment over time for each college.

Dr. Libutti noted that mental health and wellness is the number one issue for incoming students. The University is addressing wellness, mental health concerns, academic readiness, and a sense of belonging through new initiatives and programs beginning on day one.
