Athletics Director Bjorn introduced Garrett Waller and Kacey Light and proceeded with his presentation on Athletics. The presentation highlighted the following:

- Continued strong GPAs for athletes across many majors and strong representation on the Dean's list.
- Winning seasons for Men's Cross Country, Football, Men's Track and Field, and Women's Basketball.
- Increased Football revenue for the 2023/2024 season.
- Working to increase revenue for Men's and Women's Basketball through community outreach, fundraising, notable contest matchups, and a variety of other programs.
- Moving forward with several Athletic Complex upgrades and renovations, including Meade Stadium, Track and Field, Baseball, Softball, and Soccer complexes.
- Updates regarding Name, Image & Likeness (NIL). The independent collective focused on URI students is now operated by Coast-to-Coast Promotions, whose mission is to generate revenue for NIL opportunities.
- General concerns about the current NIL environment creating the possibility of illegitimate transactions, protections implemented by the NCAA, and current lawsuits the NCAA is facing.
- Introduction of a Football Champion Subdivision White Paper Concept that outlines athletics as being one portion of students' educational experience.
