3. DISCUSSION ITEM

a. Update on Classified Employees bargaining

Abby Benson, Vice President, Administration and Finance

Vice President Abby Benson provided an update on recent increases approved by the state for URI classified employees. URI currently has 781 classified employees; most of them are represented by three unions that bargain directly with the state Department of Administration (DOA). She reported that over the summer, the DOA negotiated and approved salary increases for our union and non-union classified employees; specifically, 5% effective June 30, 2024; 4% effective for FY2026 and 3% effective for FY2027.

Vice President Benson reported that URI is expecting an impact of \$1.5 million to the already approved FY2025 budget, which includes the salary increase plus fringe benefits. The total increase including all funds is approximately \$2.8 million. She noted that URI will be working with the Office of Management and Budget through the FY2026 budget process to see if we'll get some relief to address these additional salary requirements in a revised FY2025 budget.
