# Unofficial Minutes Town of Portsmouth Canvassing Authority

May 10, 2022 Portsmouth Town Hall—Council Chambers Hybrid—Zoom

Ms. Zitka called meeting to order at 3:02 PM.

- 1. Members identified themselves
- 2. Reviewed unofficial minutes from BOC meetings March 31, 2022.

  Motion made by E. Vadney to approve minutes; seconded by M. Kanter; motion carried 3-0.
- 3. Reviewed packet (see attached) containing BOC-approved EDS maps (March 31 meeting) with latest street file.
  - a. Registrar gave overview of review process:
    - 1. EDS street file compared with legislation (bills S2162 & H7323), existing Town street map, Central Voter Registration System (CVRS) street listing and voter records
    - 2. Noted: street ranges have been changed to reflect e911, tax rolls, and GIS addresses that can identify residential/commercial properties
    - 3. Discussed unique challenges with Prudence and Aquidneck Island streets with same or similar names.
    - 4. Discrepancies reported for update. Voters registered to commercial/marina or non-verifiable properties notified.
      - a. Discussed options available to voters at these addresses to cast ballots in upcoming 2022 elections: mail ballot & early in-person (with updated residence) and provisional ballot at polls.
      - b. Discussed option available to voters without permanent residence: can use Board of Canvassers address at 2200 East Main Rd.
      - c. Discussed how all precincts shifted to maintain 3000 voter limit. Voters will need check their current records and cannot assume to vote at 2020 location.
    - 5. Packet reviewed by district and separate votes were taken:
      - a. Motion made by E. Vadney to approve District 1, Precinct 2701 street listing; seconded by M. Kanter; motion carried 3-0.
      - b. Motion made by E. Vadney to approve District 2, Precinct 2702 street listing; seconded by M. Kanter; motion carried 3-0.
      - c. Motion made by E. Vadney to approve District 3, Precinct 2703 street listing; seconded by M. Kanter; motion carried 3-0.
      - d. Motion made by E. Vadney to approve District 4, Precinct 2704 street listing; seconded by M. Kanter; motion carried 3-0.
      - e. Motion made by E. Vadney to approve District 5, Precinct 2705 street listing; seconded by M. Kanter; motion carried 3-0.

- f. Motion made by E. Vadney to approve District 6, Precinct 2706 street listing; seconded by M. Kanter; motion carried 3-0.
- g. Motion made by E. Vadney to approve District 7, Precinct 2707 street listing; seconded by M. Kanter; motion carried 3-0.
- h. Board members initialed/signed Redistricting Certification to submit to the RI Department of State (DOS)

#### 4. Registrar Report

- a. Remaining steps for Redistricting Process
  - 1. Certified list submitted to the DOS for precinct assignment testing. All but 2701 have precinct numbers that changed. Will provide number of voters at each precinct.
  - 2. RI State Board of Elections requires this information to approve polls, conduct inspections, and determine equipment
  - 3. Mailing to all voters once complete
- b. Discussed Voter Registration Drive at HS & Poll Worker recruitment. Suggestions from board members and public include:
  - 1. Contacting Civics teachers for presentations
  - 2. Board members & staff attending school events to provide voter registration
  - 3. Look into reactivating high school intern program
  - 4. Planning poll worker event this summer
