- 1. Discuss and act on amending emergency ordinance pertaining to Outdoor Entertainment Licenses for all license holders to conform with the settlement agreement.
- 2. Receive and act on reports on the previous weekend's traffic enforcement effort by the R.I. State Police and report on motorized vehicle accidents requiring Rescue assistance for same time period.
- 3. Discuss and act on emergency amendments to the Town ordinances regulating motorized cycles and mopeds to deal with the emergency which has arisen regarding the public health, safety and/or general welfare of the Town. Specifically, this agenda item is required to address the following: the series of moped and other accidents this summer culminating in a moped accident fatality as well as personal injuries resulting from a constant series of moped accidents; the Town's reduced ability to deal with such accidents and injuries because the number of the Town's rescue personnel has been reduced to approximately one third as a result of personnel electing not to respond because of the COVID-19 crisis; the overwhelming of the Town's medical resources; and the overwhelming of the Town's police force and resources. The following items pertaining to motorized cycles and mopeds may be discussed and considered: reduction in the number of motorized cycles and mopeds which a license shall be permitted to rent or lease; wrist bands for authorized drivers for such purposes as identification of authorized moped drivers; adding stickers to vehicles regarding vehicle identification, improper use of horns, and dirt road prohibitions; measures to improve safety and orientation; mandatory helmets for all riders; mandatory appropriate footwear for all riders.

Also, measures to relocate training from Weldon's Way; raising the moped operator age limit; enforcement of rules pertaining to rentals on property referenced in the moped licenses; reduction of ridership to one rider per vehicle; and reduction in the hours of operation.
