NOTICE OF PUBLIC HEARING

Pursuant to the provisions of R.I. Gen. Laws §39-3-11, as amended, the Public Utilities Commission (PUC) hereby gives notice that it will conduct a hearing on **Tuesday, March 12, 2024** @ 6:00 P.M. in Hearing Room A at the PUCs office, 89 Jefferson Boulevard, Warwick, Rhode Island. The purpose of this hearing is to take public comments on The Narragansett Electric Company d/b/a Rhode Islands proposed rate change s to take effect April 1, 2024 in various dockets. The hearing will be streamed live at https://video.ibm.com/channel/WqQyXw296dg.

People interested in providing public comment at the meeting may participate in a Zoom meeting through the internet or by calling in, preferably 5-10 minutes prior to the hearing. Rhode Island Energy proposes rate changes to both electric and gas distribution rates which would take effect April 1, 2024. The rate changes would affect electric and gas customers in all rate classes. Table 1 shows the categories of changes and estimates the impact on the monthly bill of a typical residential customer taking Last Resort Service (LRS) from Rhode Island Energy. Table 2 estimates the annual impact of the proposed gas rates on a typical residential heating customers bill.

The impact on typical residential LRS customer using 500 kWh per month is a decrease of \$35.47, from \$167.94 to \$132.47 or 21.1% on the total bill. For non-residential customers, the impacts will vary depending upon the rate class and usage.

The impact on an average residential heating customer using 845 therms annually is an increase of \$48.28, from \$1,692.31 to \$1,740.59 or 2.9%. The impact on other customer rate class will vary depending upon the rate class and usage.
