RULE 41 After General Communications and prior to the Consent Calendar at the last regularly scheduled meeting of the City Council each month, there shall be a period of time, not to exceed thirty (30) minutes, during which citizens may comment about Warwick City Government issues subject to the following stipulations:

- a. <u>The total period of time for public comment shall not exceed thirty (30) minutes.</u> <u>Comments need to be brief in order to allow as many citizens as possible to</u> <u>participate. Each citizen signed up and present shall have not to exceed five (5)</u> <u>minutes to speak, provided, however that if more than six (6) Citizens are signed</u> <u>up and present the thirty (30) minutes will be split evenly amongst speakers. Time</u> <u>shall not be transferable amongst speakers.</u>
- b. The topics for comment shall be issues directly affecting City government.
- c. <u>City Council members will not respond to questions during the public comment</u> <u>period.</u>
- d. <u>The public comment session will terminate at the expiration of the earlier of all</u> <u>speakers concluding their allotted time or thirty (30) minutes. Waiver of this</u> <u>provision requires a unanimous vote of the Council.</u>
