1. CASE 23.026, 300 WEST EXCHANGE STREET, George S. Smith Engraving Company, 1900 (PLD-ICBD)

The applicant is requesting the construction of an approx. 4,300 sq. ft. addition to the third story.

# 2. CASE 22.028, 126 POWER STREET, House, pre1908 (COLLEGE HILL)

The applicant is requesting the restoration/rehabilitation of the south (front) porch, the removal of a window and the installation of a door with hood, landing and stairs, west (side) elevation and the relocation of the removed window to the north (rear) elevation, first floor.

#### 3. CASE 23.027, 40 STIMSON AVENUE, Edward S. Clark House, 1892 (STIMSON)

The applicant is requesting the replacement of the existing slate roof with an architectural shingle roof.

#### 4. CASE 23.028, 107 BENEVOLENT STREET, Carriage House 18 (POWER-COOKE)

The applicant is requesting installation of insulated replacement windows; modification of existing openings and installation of windows, 1<sup>st</sup> floor, installation of balcony (rear) elevation, as part of the rehabilitation of the building.

# 5. CASE 23.030, 12 GIBBON COURT, House, 1860 (ARMORY)

The applicant is requesting the installation of 27 solar panels, 12 to the east and 15 to the west of the gable end roof.
