The Town of Barrington is working with a team from Libra Planners to analyze our Zoning Ordinance to identify ways to support the creation of more high quality, affordable housing in Town. To ensure this analysis is responsive to Barrington's needs, a community workshop is being held to get feedback from residents and stakeholders. This 90-minute workshop will introduce the project before moving into engaging activities that will allow participants to learn about and discuss housing preferences with neighbors, Town officials, and the consultant team. Refreshments will be provided and the format will be family friendly.
