# RESOLUTION AUTHORIZING THE GRANTING OF AN EASEMENT TO INSTALL, MAINTAIN, REINSTALL AND REPAIR A LOOP DETECTOR FOR A TRAFFIC SIGNAL FOR THE PROPERTY LOCATED AT 2000 PAWTUCKET AVENUE

WHEREAS, the City of East Providence, the owner of property located at 2000 Pawtucket Avenue, Map 406, Block 6, Parcels 1 & 5 desires to grant an easement to the State of Rhode Island, Department of Transportation to enter upon a portion of the City's property hereinafter referred to as the "Loop Detector Easement Area"; and

WHEREAS, to accomplish the entry, an easement is necessary over City-owned property as set forth in the Permanent Loop Detector Easement Agreement attached hereto; and

WHEREAS, Rhode Island General Laws §45-2-4 empowers the City Council to grant interest in property.

#### NOW, THEREFORE BE IT RESOLVED,

- (1) The City Council of the City of East Providence authorizes the granting of an easement to install, maintain, reinstall and repair a loop detector for a traffic signal;
- (2) The Mayor, by and through the office of the City Solicitor, is hereby empowered to take all necessary steps to grant and perfect an easement consistent with the Permanent Loop Detector Easement Agreement attached hereto;
- (3) Execute a Full Release for the Permanent Traffic Signal Control Easements designated as Parcels 1P-1 and 1P-2 totaling 560 square feet as shown on State Highway Plat 2878;
- (4) Execute a Permanent Loop Detector Easement (of 1,001 Sq. Ft.) necessary for the new traffic signal being installed at the entrance to the High School allowing RIDOT to install and maintain the inductance loop detectors.

#### A RESOLUTION REQUESTING GOVERNOR RAIMONDO TO RELEASE CARES ACT'S CORONAVIRUS RELIEF FUNDS TO CITIES AND TOWNS

WHEREAS, the Governor and municipal leaders across the state have declared a state of emergency as a result of COVID-19; and

WHEREAS, municipal leaders have worked cooperatively and productively with the state administration to respond to and contain the virus; and

WHEREAS, cities and towns have been given guidance that there will be delays in receiving reimbursements from the Federal Emergency Management Agency (FEMA) for qualifying COVID-19 related expenses; and

WHEREAS, the state has received \$1.25 billion dollars under the CARES Act's Coronavirus Relief Fund (CRF) to cover state and municipal costs associated with the emergency; and

WHEREAS, the U.S. Department of the Treasury has stated that the Coronavirus Relief Fund may be used for COVID-19 expenses not otherwise reimbursable by FEMA, including public safety expenditures personnel costs associated with COVID-19 response, and the mandatory local match for expenses submitted to FEMA; and

WHEREAS, according to the National League of Cities, Rhode Island is one of only three states that have not distributed a portion of their Coronavirus Relief Fund to local governments; and

WHEREAS, cities and towns across Rhode Island face potential revenue risks resulting from the economic impacts of COVID-19, including a possible reduction in state aid programs, lower collection rates of property taxes, and other business activity revenue losses, all of which could exceed \$100 million; and

WHEREAS, the state has withheld scheduled state payments in the current fiscal year by over \$50 million dollars through the end of September 2020; and

WHEREAS, the state has not yet completed a budget for Fiscal Year 2021, creating even greater uncertainty about expected aid to local governments and school;

**NOW THEREFORE, BE IT RESOLVED,** that this City Council calls on the Governor to execute a plan for distributing CRF funds to cities and towns, taking into account expenses incurred and revenues lost by each city and town as a result of the emergency. And be it further resolved that the Council urges the General Assembly to support total state aid to local governments at the same aggregate level as in FY 2020-2021.
