# a. Comprehensive Review of President Parlange – *Chair Cook to provide survey and interview updates.*

Policy on Presidential Performance Review

Chair Cook stated that the comprehensive review is required by policy prior to the expiration of the president's employment contract in June 2024. She said that the review will be completed by the end of this year, with work on contract renewal terms planned for early next year.

Chair Cook reported that the comprehensive review includes reaching out to different constituents using a survey that can give the Board feedback on the president. She noted that the Board must keep in mind that President Parlange has just released the strategic plan and is in the beginning of his influence and impact at the University. She stated that the survey itself is aligned with the strategic plan and its four major goals.

The survey will go out to a wide range of URI stakeholders within the URI community, including students, faculty and staff, alums/external stakeholders, governmental leaders, and the Board of Trustees. Interviews may be conducted following review of the survey results.

Board members reviewed draft letters prepared to introduce the survey to URI stakeholders and provided feedback. Staff were encouraged to make clear in all communications the purpose of the survey. Board members reviewed the groups being surveyed and discussed the value of identifying how each stakeholder group responded. Board members noted that the board will draw on the survey results when it assesses the president.

The committees will meet again to review the results of the survey. Committee members were asked to share additional comments with either Chair Cook or Board Secretary Michelle Curreri.
