Enclosure 2.a.

Committee Chair Kerwin noted that this item was also a topic at the Institutional Risk and Compliance Committee meeting held on September 13, 2023. That committee recommended that the Board of Trustees approve the proposed action. Dr. Bethany Jenkins introduced Dr. Elin Torell, Coastal Resources Center, Director for International Programs, and Sarah Gaines, who presented the background of this opportunity. Dr. Torrell explained that this is one of the most biodiverse environments in the world and a great research opportunity for URI.

Committee Chair Kerwin noted that proposed amendments to the Honorary Degree Policy are being reviewed by the Academic Affairs and Research Committee, as the committee is responsible for the formal awarding of degrees, certificates and honors. Dr. Barbara Wolfe and Dr. Dan Moos explained that proposed amendments include changes to the process and intent of the policy related to URI's annual honorary degree conferral.

Provost Wolfe reported that classes have started and provided an enrollment update. She announced the hiring of Dr. Christopher Lavan for the role of Associate Vice Provost for Advancement of Teaching and Learning, as well as 39 new tenure-track faculty, 13 teaching track faculty, and 10 new lecturers.

Provost Wolfe called upon Dr. Kristin Johnson to provide an update on Global initiatives. Dr. Johnson explained that URI is now approaching pre-COVID levels of student mobility, and the most common destination for our study abroad students is Spain. She reported that we currently have 411 students from 43 countries visiting URI.
