# 2. REPORT OF THE CHIEF ACADEMIC OFFICER Enclosure

Dr. Barbara Wolfe, Provost and Executive Vice President, Academic Affairs

- a. Review progress of University academic performance metrics.
- b. Review of academic efforts in support of student success, including academic advising, career development support, experiential learning, academic enhancement center, undergraduate research, and innovation projects.

Provost Wolfe shared that URI hosted it's first in-person Academic Summit since 2020 in January. The theme of the Summit was AI (artificial intelligence). The main speaker was Dr. Sid Dobrin; the event was highly successful. She then provided a detailed overview of URI's key performance metrics (KPIs), and provided student success updates, as mandated by the committee's yearly schedule of topics.

She touched on the successful Winter J Term, which just completed and had a 19 percent increase in student enrollment. She then announced to the committee that URI's newly hired dean of the College of Health Sciences, Dr. Patrick Vivier, the new dean of the College of Nursing, Dr. Danny Willis, and new dean of the College of Pharmacy, Dr. Kerry LaPlante, were present for this meeting. Provost Wolfe then provided updates on recent faculty awards and honors. The Provost's presentation is linked <u>here</u>.

In reviewing the strategic KPIs, Dr. Dean Libutti joined the discussion to provide answers to questions. Dr. Anne Veeger provided answers to questions regarding AI, with regard to students and faculty. President Parlange commented on the plan to ask for more funding from the state to improve our ratio of students to advisors.
