#### f. Conflict Disclosure Form

Committee Chair Nicolato stated that management of conflicts is critically important for public bodies. The State of Rhode Island Code of Ethics requires board members to complete annually a financial disclosure form to identify potential financial conflicts. The URI Board of Trustees does not presently have its own conflict-of-interest form but will look for examples from other universities and the Association of Governing Boards. Committee members discussed the disclosure of board members' work with other boards and commissions where decisions made may impact the University. Committee Chair Nicolato suggested that the committee review a draft conflict disclosure form at the September meeting.

Committee members discussed the URI Board of Trustees Statement of Expectations form that was created in 2021 and signed by all members. Each new board member is expected to review and sign the form at the start of their term. Committee members suggested adding conflict of interest language to the Statement of Expectations.
