2. DISCUSSION ITEMS

a. Conflict Disclosure Research Update

Committee Chair Nicolato reported that the Board's administrative staff is creating a conflict disclosure summary, listing the responses that board members provided to the Rhode Island Ethics Commission on the latest annual financial disclosure forms. The disclosure summary will be presented to the Governance Committee at its February meeting. Ethics training is planned for the February Board meeting, preceding the next due date for all board members to complete their disclosure forms. Committee Chair Nicolato thanked the team for continuing to provide best practices and standards related to the work of the board.

b. Establishment of Board Goals - Development of KPIs

Committee Chair Nicolato stated that, due to the compressed timeline between the September and the October meetings, this item is being deferred to the next Governance Committee meeting. She thanked Committee Vice Chair Placencia for taking the lead on this important work.

c. Preparation of 2023 URI Board of Trustees Annual Report

Committee Chair Nicolato noted that the Board of Trustees Annual Report provides the governor with an update on the board's activities throughout the past year, sharing information about board members themselves, their participation on committees and important projects. She stated that a coordination of effort is in order as we prepare for the next report to the governor. She asked Interim Chief of Staff Chelsea Berry to speak about the University's plans for an annual report.

Interim Chief of Staff Chelsea Berry reported that URI is moving towards an annual university report to highlight the good work that is happening at URI. The report can include a message from the board, listing the trustees, to be distributed to the governor and other elected officials. She suggested a consolidation of effort to create one robust report that can serve many different functions. The report would correlate with the university's academic cycle to be published in the summer.

Committee Chair Nicolato stated that a memo can be prepared to send to the governor in advance of the board member appointment and reappointment process. She thanked Chelsea for taking the lead to make sure URI provides the best resources possible for our elected officials.

3. ACTION ITEM

a. Review of Proposed Amendments to the University's Policy on the Awarding of Honorary Degrees, and recommendation for approval to the URI Board of Trustees.

Dr. Dan Moos reported that the University's Policy on the Awarding of Honorary Degrees is up for a scheduled review. He noted that the proposed amendments redlined in the enclosure were reviewed and discussed by both the Governance Committee and the Academic Affairs and Research Committee at their September meetings. No additional amendments are suggested.

Dr. Moos reviewed the proposed amendments to the policy, including:

- New language expressing the intent for recipients to have "exceptional achievements", "serve as inspiring examples", and "bring honor to the University".
- Recipients are no longer required to appear at the Main Commencement Ceremony, but at an "appropriate or agreed upon Commencement Ceremony".
- Adjustment to eligibility: Faculty, staff, and students, as well as political office seekers and holders, remain ineligible for three years after the conclusion of their term/service (Current version references only "current" faculty, staff, students, and political office seekers and holders.)

Committee Chair Nicolato called for a motion that the Governance Committee recommend that the Board of Trustees approve the proposed amendments to the URI Board of Trustees Policy on Awarding of Honorary Degrees, as recommended and presented.

On a motion duly made by Robert Weygand and seconded by Charles Fogarty, and hearing no discussion, it was
