#### **Public Comments:**

Commissioner Ahern reviewed the Public Comments parameters. 10 people provided comments on the following topics:

- Equitable Social Justice
- Social Equity Applicant licensing issues
- Support of the Social Equity Fund by licensing fees vs penalties
- Mobilizing the Social Equity fund as soon as possible for smaller start ups
- Social equity, applicant standard opportunities for research and education in the hemp industry and meaningful collaboration between the CCC and the Advisory Board
- Portion of profits be allocated to youth prevention
- Worker-owned cooperatives
- Cooperative ownership model needed for achieving social and economic justice in the cannabis industry; including democratic governance, financial ownership for workers with the stronger protection, access to benefits, training and institutional support through Union membership
- Give communities harmed by the war on drugs, the opportunity to participate in the cannabis market and build equity skills and community in cannabis industry
- Provisional and/or conditional licenses before full receiving full license
- Capital Allocation
- Clear and consistent labeling; Remediation; Allergic reactions
- Study other states who have successful programs
- Advocation for more retail points
- Discussion about difficulties that small businesses face
- Statements about inconsistent statutes surrounding criminal background checks
- Clarification needed regarding law enforcement, vehicle searches, drug recognition experts, off-duty use, protection against discrimination.
- Statutes and standards for criminal proceedings need clarification.
- Clarification needed for employees' cannabis use and the stability of their employment
- Cannabis College education challenges and funding
- Taxes on medical vs recreational usage
- Multi-year registration
