Chairperson Ahern welcomed new Cannabis Control Commission staff members Kelsey McQueeney and Mariana Ormonde.

### A presentation by Stephanie Forschner-Dancause, Ph.D., Program Coordinator for the University of Rhode Island College of Pharmacy Certificate of Cannabis Studies Program and Lecturer.

#### **Presentation included:**

- A history of cannabis medicinal use and prohibition in the world and the United States.
- An overview of the cannabis studies programs at the University of Rhode Island.
- Chemistry produced by the cannabis plant.
- Cannabis Pharmacognosy.
- Chemistry and biological activity of natural cannabis and other natural plants.
- An introduction to the endocannabinoid system and the biological effects of cannabis on the human body.

Discussion ensued at the completion of the presentation, the commissioners asked questions regarding the presentation. Ms. Forschner-Dancause responded to their questions with additional information on the following:

- The molecular structure and potency of hemp versus cannabis.
- Potential benefits of cannabis use for patients/individuals with opioid additions.
- Potential effects of cannabis use on patients/individuals with mental illness.
- Studies conducted regarding cannabis use by disabled veterans or people with preexisting health conditions.
- The cannabis program at URI
- Risks of contamination and presence of contaminants in cannabis, including heavy metals and mold.
- Testing procedures in the manufacturing process to prevent contaminants.

The next order of business was:

#### Public Comment (in person only):

One person (Stuart Procter, Ph.D., Cannabis Advisory Board member) provided public comments on the following topic:

• Whether traces of heavy metals and micro-toxins such as yeast or mold that may be present in cannabis products and unknowingly consumed, could contribute to health and mental health issues in consumers, noting that further testing is required.
