MOTION that the Burrillville Town Council appropriate and transfer \$125,000 from the General Fund Unassigned Fund Balance (0100- 307500) to the Invenenergy Tax Agreement Fund (fund #0286) for the purpose of funding legal and professional services for LS Power negotiations and EFSB ESA legislation.
- B. MOTION that the Burrillville Town Council appropriate and transfer \$100,000 from the General Fund Unassigned Fund Balance (0100- 307500) to the Revaluation Project Fund (fund #1220).
- C. MOTION that the Burrillville Town Council appropriate and transfer \$125,000 from the General Fund Unassigned Fund Balance (0100- 307500) to the Economic Redevelopment/Development Fund (fund #1110).
- D. MOTION that the Burrillville Town Council appropriate and transfer \$75,000 from the General Fund Unassigned Fund Balance (0100- 307500) to the Unfunded Sick/Vac Leave Reserve (Unfunded Liabilities) Fund (fund #3810).

- E. MOTION that the Burrillville Town Council appropriate and transfer \$25,000 from the General Fund Unassigned Fund Balance (0100- 307500) to the Other Post-Employment Benefits (OPEB) Fund (fund #3805)
- F. MOTION that the Burrillville Town Council appropriate and transfer \$85,056.86 from the General Fund Unassigned Fund Balance (0100- 307500) to the Animal Control Facility Renovation Fund (fund #0575).
- G. MOTION that the Burrillville Town Council appropriate and transfer \$7,250 from the General Fund Unassigned Fund Balance (0100- 307500) to the Health Care Contingency Fund (fund #3800).
