Revised Freshwater Wetlands Rules have been finalized and will go into effect on July 1, 2022: As part of recent rulemaking, the Department filed new Rule and Regulations for Administration and Enforcement of the Freshwater Wetlands Act (250-RICR-150-15-3) that extend the effective date for the new rules from January 15, 2022 to July 1, 2022. During the transition period, the existing Freshwater Wetlands Rules(250-RICR-150-15-1) will remain in place.
